

Official Raffle Contest Rules

OFFICIAL CONTEST RULES: By participating, you agree that:

1. These Official Contest Rules may not be waived, modified, or supplemented except by Providing Hope. No modification of these official contest rules shall be enforceable unless made by Providing Hope.
2. The raffle drawing shall be held at Providing Hope in Fredericksburg, Virginia. All tickets must be purchased by the drawing date (April 11, 2020) to be eligible for the drawing. The drawing will take place regardless of the amount of tickets sold, all prizes are guaranteed regardless of ticket sales.
3. Each ticket will be entered separately in the drawing. Each ticket is a separate and equal chance to win the specified prize.
4. Winner has 30 days to make arrangements regarding possession of the prize at Providing Hope in Fredericksburg, Virginia, or forfeits all claims thereto.
5. Prizes: The GRAND prize is a 2020 Keystone Fuzion Toyhauler (see details on giveaways page), 2nd prize Canam Maverick X3 Turbo RC, 3rd prize \$10,000 cash, 4th prize is \$5,000 Cash, 5th prize is \$2,500 cash, 6th-10th \$500 cash. Cash in lieu of GRAND prize is \$55,000 cash.
6. Entries for the drawing are sold at www.providinghopeva.com.
7. A maximum number of 2,500 tickets will be sold. Odds of winning the GRAND prize are determined by the total number of entries, with the maximum odds of 1:2,500. Odds of winning a prize (10), with maximum odds of 1:250. After the drawing, the winner will be contacted based on the name and information provided during ticket purchase. To pick up a vehicle, two forms of identification, one of which must be a photo ID will be required to prove that this person is the person on the winning ticket. Purchasers do not need their ticket receipts for any reason. However, the receipts will be kept on file by Providing Hope.
8. Tickets are sold in numerical sequence.
9. Winner notification will be made by telephone, email or mail.
10. Participant must be at least 18 years old. Winner may be required to sign an affidavit of eligibility at the discretion of the Providing Hope.
11. Providing Hope Va will pay the 24% IRS winners tax, winner is solely responsible for registration, title, transfer fees, license duties, insurance and all expenses in claiming, registering and using prizes. This may include sales taxes and property taxes. Providing Hope Va will deliver within the continental US.
12. Vehicles will not be modified by Providing Hope to meet specific local, state or country requirements.
13. Providing Hope will submit tax payment to the IRS. After the end of the year, Providing Hope will file a form W-2G with the IRS to report the value of the prize won and the taxes paid in for the winner. The winner will receive a copy of this also. Winner is solely responsible for any state and local taxes.
14. All non-US residents will be required by IRS regulations to pay 30% US income tax on the value of the prize unless the winner is a resident of specific countries exempted by treaty. This amount will be due upfront or withheld from the cash prize and submitted to the IRS on behalf of the winner. After the end of the year, the Providing Hope will file a Form 1042 and 1042-S to report the value of the prize won and the taxes paid in by the winner. The winner will receive a copy of this also. Non-US resident winner is solely responsible for any state and local taxes
15. In the event a unique Prize was lost, damaged, destroyed, or otherwise not available, Providing Hope's liability shall be limited to refund of ticket price to participants. Providing Hope's liability for any other claim is limited to refund of ticket prices.

For raffles in which a trip is the prize, and the prize specifically includes airfare, Providing Hope will book the flight itinerary for a coach flight with times and number of stops at Providing Hope's discretion. For cruise prizes, the winner will receive a cruise on that specific ship on that specific date as advertised. Winner forfeits prize value if unable to go on that date.
17. Winner agrees to the use of his/her name, address, photograph or videotape likeness and statements for publicity purposes by Providing Hope, and agrees to sign a publicity release without any further compensation.
18. Providing Hope, reserves the right to cancel this contest at any time, in which event its liability is limited to refund of ticket prices to participants. Model year and vehicle options advertised are based on availability.
19. Ticket sales to Providing Hope, board members and their immediate families are prohibited. Immediate family includes spouse, children, and children's spouse.
